

## VSS Board Meeting Minutes

7. Old Business

a. The board approved the recommendation of the rules committee to modify the home run rule to allow 3 over the fence home runs per game with additional balls hit over the fence being outs. Yes-5; No-1.

b. The draft schedule was discussed. Reasonable effort has been made to balance the number of scheduled games each team plays at Henry Park and to balance the number of games each team plays each day of the week. The draft schedule was approved 6-0 and will be posted on the website.

8. New Business

a. The board discussed potential ways to give business to Rainbow Graphics (sponsor) this year as we will not be ordering many shirts or hats. Based on budget availability, the board will consider purchasing basic shirts in different colors for the fall league later in the year.

b. We will mark the game balls with team names/initials to assist in retrieving the balls hit foul or over the fence during games. We will purchase some buckets to collect and store the used game balls. The used game balls will be kept separate and distinct from the batting practice balls and public use balls in the sheds. The used game balls will be the spare balls during the games. Managers will be instructed to lock these buckets in the shed at the end of games.
